Covered actions include, but are not limited to weatherization (such as insulation and replacing windows and doors); programmed lowering of thermostat settings; placement of timers on hot water heaters; installation or replacement of energy efficient lighting, low-flow plumbing fixtures (such as faucets, toilets, and showerheads), heating, ventilation, and air conditioning systems, and appliances; installation of drip-irrigation systems; improvements in generator efficiency and appliance efficiency ratings; efficiency improvements for vehicles and transportation (such as fleet changeout); power storage (such as flywheels and batteries, generally less than 10 megawatt equivalent); transportation management systems (such as traffic signal control systems, car navigation, speed cameras, and automatic plate number recognition); development of energy-efficient manufacturing, industrial, or building practices; and small-scale energy efficiency and conservation research and development and small-scale pilot projects. Covered actions include building renovations or new structures, provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standard-settings, or proposed DOE legislation, except for those actions listed in B5.1(b) of this appendix. (b) Covered actions include rulemakings that establish energy conservation standards for consumer products and industrial equipment, provided that the actions would not: (1) have the potential to cause a significant change in manufacturing infrastructure (such as construction of new manufacturing plants with considerable associated ground disturbance); (2) involve significant unresolved conflicts concerning alternative uses of available resources (such as rare or limited raw materials); (3) have the potential to result in a significant increase in the disposal of materials posing significant risks to human health and the environment (such as RCRA hazardous wastes); or (4) have the potential to cause a significant increase in energy consumption in a state or region.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to TRC Energy Services to design, deploy, and evaluate the performance of integrated technology packages that combine advanced lighting, fenestration, and heating, ventilation, and air conditioning (HVAC) technologies.

During the design phase, the proposed activities would include site visits, data collection and development of computer simulation models for savings estimation. Proposed deployment activities would include installation of selected technologies at the demonstration sites, and evaluation of energy savings through collection and analysis of energy consumption data from energy meters. Proposed activities would also include documentation and communication of project results to a wide variety of stakeholders in the industry.

Deployment activities would result in changes to select building components and systems. These may include changes to existing lighting, window shading systems, HVAC systems, energy management systems, and building controls, as well as the addition of window films. However, these changes would be limited to upgrades/retrofits on existing components and systems and would not result in significant changes to the interior or exterior structures of the chosen buildings. The exact sites for deployment and testing have not been identified yet; therefore, they cannot be listed. However, the two or three selected sites would be located on campus at either Stockton University or Princeton University. Based on the activities proposed, DOE does not anticipate any potential to cause effects to historic properties, assuming they were present; therefore, DOE has no further obligations under section 106 of the National Historic Preservation Act. DOE does not anticipate any impacts to resources of concern--natural, cultural, or historic—due to the proposed activities of the project.

The proposed project would involve minor construction activities which would be limited to the removal of old lighting, and/or modification of mechanical and building envelope components and building controls. The removal of old lighting and any replacement with new LEDs could cause some small amount of waste to be generated if pieces of ceiling tiles, drywall, etc. get damaged. Similarly, the process of installation of blinds could cause some dust and debris as a result. Overall, only a small amount of waste through this project is expected. TRC would segregate waste into different categories such as recyclable, e-waste, and landfill trash and employ its established waste management best practices.

Based on the review of the proposal, DOE has determined the proposal fits within the class of action(s) and the integral elements of Appendix B to Subpart D of 10 CFR 1021 outlined in the DOE categorical exclusion(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410 (2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant actions, or an improper interim action. This proposal is categorically excluded from further NEPA review.
