**A9** Information gathering, analysis, and

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and dissemination informational programs), but not including site characterization or environmental monitoring. B3.6 Smallscale research and **laboratory** operations, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a development, concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Covered actions include, but are not limited to, burn tests (such as tests of electric cable fire resistance or the combustion characteristics of fuels), impact tests (such as pneumatic ejector tests using earthen embankments or concrete slabs designated and routinely used for that purpose), or drop, puncture, waterimmersion, or thermal tests. Covered actions would not involve source, special nuclear, or byproduct materials, except encapsulated sources manufactured to applicable standards that contain source, special nuclear, or byproduct materials may be used for nondestructive actions such as detector/sensor development and testing and first responder field training.

### Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Boston University to develop selfcleaning solar mirrors and solar panels with the application of transparent, electrodynamic screen (EDS) for nearcontinuous dust removal from solar collector surfaces. A previous, final NEPA Determination (GFO-0007119-001; CXs A9, B3.6, B3.11; 09/18/15) reviewed all project activities. Since that time, changes have been made to the Statement of Project Objectives (SOPO). This NEPA Determination is to review these minor SOPO changes and to include updated language into the award contract involving DOE NEPA requirements for proposed international activities.

Proposed activities would include the design, development, fabrication and field testing of self-cleaning solar mirrors and panels. Design and development would take place at the Photonics Center on campus at Boston University in Boston, MA. Fabrication of EDS films would be undertaken by Corning, Inc. from their industrial facility in Corning, NY in collaboration with the Industrial Technology Research Institute in Chuung, Hsinchu, Taiwan. Optical modeling and field testing would be completed by Sandia National Lab (SNL) at their solar thermal test site in Albuquerque, NM. Further field testing would be conducted at NRG Energy's Ivanpah solar plant and Geodrill's Atacama solar plant in the Atacama Desert in Chile.

Proposed SOPO modifications are limited to continuity of the final project phase, specifically a requested schedule extension of Phase 3 to 6/30/2019. There would be no changes in the nature and scope of work, locations, or project participants. Project activities would remain the same as reviewed in the prior NEPA Determination for this award, and overall project objectives would not be affected by the proposed schedule change. Project activities would still fall within the category of actions covered by the CXs that were previously applied to this award; therefore, the rationale of the original NEPA determination is still applicable and no further NEPA review is necessary.

Any work proposed to be conducted at a DOE laboratory may be subject to additional NEPA review by the cognizant DOE NEPA Compliance Officer for the specific DOE laboratory prior to initiating such work. Further, any work conducted at a DOE laboratory must meet the laboratory's health and safety requirements.

Based on the review of the proposal, DOE has determined the proposal fits within the class of action(s) and the integral elements of Appendix B to Subpart D of 10 CFR 1021 outlined in the DOE categorical exclusion(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410(2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant actions, or an improper interim action. This proposal is categorically excluded from further NEPA review. Further, DOE has determined that the work to be carried out is exempt from further review pursuant to Section 5.1.1 of the DOE Final Guidelines for Implementation of Executive Order 12114; "Environmental Effects Abroad of Major Federal Actions."
