Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

- A9 Information gathering, analysis, and dissemination** Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)
- B3.6 Small-scale research and development, laboratory operations, and pilot projects** Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy is proposing to provide funding to UIUC complete a laboratory-scale research and development project improve performance of solar cells grown on silicon (Si). The project would be completed over a single Budget Period.

During the project, III-V solar cells would be grown on Si by molecular beam epitaxy using different dopant atoms. The cells would be processed in a cleanroom and tested for device characteristics. In addition, the materials and devices would be characterized by a range of scanning electron microscope techniques including electron beam-induced current, cathodoluminescence, electron channeling contrast imaging, and atom probe tomography.

Project activities would be completed in dedicated laboratory facilities at UIUC and University of California at Santa Barbara. The project would involve the use and handling of various hazardous materials, including phosphorus, strong acids, and industrial solvents. All such handling would occur in-lab. All hazardous materials would be managed in accordance with Federal, state, and local environmental regulations. Existing university health and safety policies and procedures would be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
