**B5.1 Actions** to conserve energy or water

(a) Actions to conserve energy or water, demonstrate potential energy or water conservation, and promote energy efficiency that would not have the potential to cause significant changes in the indoor or outdoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, manufacturers, and designers), organizations (such as utilities), and governments (such as state, local, and tribal). Covered actions include, but are not limited to weatherization (such as insulation and replacing windows and doors); programmed lowering of thermostat settings; placement of timers on hot water heaters; installation or replacement of energy efficient lighting, low-flow plumbing fixtures (such as faucets, toilets, and showerheads), heating, ventilation, and air conditioning systems, and appliances; installation of drip-irrigation systems; improvements in generator efficiency and appliance efficiency ratings; efficiency improvements for vehicles and transportation (such as fleet changeout); power storage (such as flywheels and batteries, generally less than 10 megawatt equivalent); transportation management systems (such as traffic signal control systems, car navigation, speed cameras, and automatic plate number recognition); development of energy-efficient manufacturing, industrial, or building practices; and small-scale energy efficiency and conservation research and development and small-scale pilot projects. Covered actions include building renovations or new structures, provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standard-settings, or proposed DOE legislation, except for those actions listed in B5.1(b) of this appendix. (b) Covered actions include rulemakings that establish energy conservation standards for consumer products and industrial equipment, provided that the actions would not: (1) have the potential to cause a significant change in manufacturing infrastructure (such as construction of new manufacturing plants with considerable associated ground disturbance); (2) involve significant unresolved conflicts concerning alternative uses of available resources (such as rare or limited raw materials); (3) have the potential to result in a significant increase in the disposal of materials posing significant risks to human health and the environment (such as RCRA hazardous wastes); or (4) have the potential to cause a significant increase in energy consumption in a state or region.

#### Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Institute for Market Transformation (IMT) to support states in successfully implementing their building energy codes by accurately measuring and comparing implementation status in the field against an established baseline, using an established DOE methodology. Fieldwork would occur within Utah and Arizona. This component of the project includes coordination with Pacific Northwest National Laboratory (PNNL) on data analysis. Various sub-recipients would support training development and/or delivery activities at their offices in Utah, Arizona, and Colorado.

Proposed project activities include establishing a statistically relevant baseline against which to measure compliance improvements in Utah and Arizona, identifying the most significant reasons for local non-compliance in each target jurisdiction, addressing barriers to non-compliance, engaging and training stakeholders on energy code compliance, and developing market-ready strategies that could be continued in the future. Baseline field data collection would take place at a minimum of 126 single-family residential construction sites in each state. Training of key audiences (e.g., builders, building officials, state and local governmental agencies, etc.) would take place at various locations in each state within classrooms or on existing construction sites.

Data collection in the field would focus on key items such as envelope and duct tightness; wall, ceiling, and foundation insulation; windows; and lighting. There would be no physical modifications or ground disturbing activities required for project activities. No modifications to permits or new permits, additional licenses and/or authorizations would be needed. All homes selected for field testing would be single-family homes permitted under the current building code that are currently under construction or have been constructed within the past six months but are not yet occupied, therefore there would be no impacts to historic properties as a result of project activities. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

#### **NEPA PROVISION**

DOE has made a final NEPA determination.

### FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
