Description:

A9 Information gathering,

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information analysis, and dissemination (including, but not limited to, document publication and distribution, and classroom training and dissemination informational programs), but not including site characterization or environmental monitoring. B3.6 Smallscale **laboratory** operations, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and research and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a development, concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the University of Toledo (UT) to fabricate and characterize novel all-perovskite tandem solar cells (APTSCs). New fabrication processes would be developed for both solar cells and mini-modules. The project would be completed over two Budget Periods (BPs), with a Go-No/Go Decision Point in between each BP.

Proposed project activities would include material characterization, material processing development, perovskite cell fabrication/optimization, degradation testing, and performance optimization. All project activities would be performed by the University of Toledo at existing, purpose-built laboratory facilities. Solar cell synthesis, fabrication, and characterization would be performed at UT's Research and Technology Complex 1, at its campus in Toledo, OH. Microscopy and imaging characterization of solar cells would also be performed at the National Renewable Energy Laboratory in Golden, CO. No changes in the use, mission, or operation of existing facilities would be required. Likewise, no additional permits or authorizations would be required.

The project would involve the use and handling of various semiconductors, acids, and solvents. All such handling would be performed in laboratory environments in adherence to established health and safety policies and procedures. Protocols would include employee training, the use of personal protective equipment, engineering controls, monitoring, and internal assessments. During solar cell fabrication, all emissions would be purged through a fume hood into an exhaust system. Any hazardous waste generated by the project would be managed in accordance with existing laboratory policy and would be disposed of at a licensed Hazardous Waste Treatment, Storage, and Disposal Facility. UT would observe all Federal, state and local health, safety, and environmental laws and regulations.

NEPA PROVISION

DOE has made a final NEPA determination.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

The proposed action is categorically excluded from further NEPA review.
