Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the National Association of State Energy Officials to perform baseline energy code field studies in two home rule states to determine current building practices and enhance energy code education, training, and outreach to builders, building officials, and home energy raters in both states. NASEO and project partners would conduct the baseline studies. Results would be disseminated through presentations at conferences on related energy code topics, NASEO-hosted meetings and conferences, website, emails, and through program partners as appropriate.

The field study component of the project includes inspection of homes (prior to occupancy) being constructed by private industry. The homes would be visited at various phases of construction to collect information detailing the building practices being used by private builders to construct the homes. This data would then be analyzed to determine if energy savings could be realized by providing targeted training to building industry professionals on specific elements of construction that are relevant to the building energy code. Although exact locations of the field study inspections have not yet been determined, proposed project activities consist exclusively of intellectual, academic, or analytical activities such as information gathering, data analysis, and data dissemination. DOE has determined that the project activities would have no potential to cause effects to historic properties, assuming they were present, therefore DOE has no further obligations under section 106 of the National Historic Preservation Act. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
