Draft Request for Proposals - 89233224RNA000008 for the Management and Operation of the Savannah River Site

The Department of Energy, National Nuclear Security Administration (DOE/NNSA) has posted the draft solicitation for the Savannah River Site (SRS) Management and Operating (M&O) Contract Competition. The Draft Request for Proposals (RFP) No. 89233224RNA000008 is available for public review at the SAM.gov, FedConnect, and NNSA websites.

NNSA is seeking comments from prospective Offerors on the Draft RFP, particularly Solicitation Sections B-H, L, M, the Statement of Work. Additionally, NNSA is seeking feedback on incentive structures for all CLINs including CLIN 0004A -Savannah River Plutonium Processing Facility (SRPPF).

Additionally, please note the following:

- Section B, Clause B-2 Contract Type and Value NNSA is considering a hybrid fee structure consisting of Fixed Fee and Award Fee for Contract Line-Item Number (CLIN) 0002 for the NNSA Management and Operation of the Savannah River Site.
- Section F, Clause F-3 Period of Performance NNSA is considering a 20-year period of performance (five-year base period with two five-year option periods, one three-year option period, and one two-year option period) for the SRS M&O Contract.
- The fee structure of each CLIN is detailed in Section L, Attachment H Price and Fee Spreadsheet. The Contract Transition Period CLIN will be Firm-Fixed-Price
- Section J Appendix A Statement of Work (SOW) the full draft Statement of Work (SOW) is provided.

Other information for prospective Offerors:

- NNSA and DOE-Environmental Management (EM) are in the process of transitioning the primary ownership of the SRS. This action will be completed prior to the commencement of any performance resulting from any award associated with this procurement effort. The reading room will contain information on this effort and other information not available publicly.

All comments, suggestions, and feedback for the draft RFP shall be submitted to SEB10@nnsa.doe.gov by 2:00 pm Eastern Time, November 8, 2024. General responses shall be no longer than five pages. SRPPF incentive feedback shall be no longer than two pages. Non-SRPPF incentive structure feedback shall be no longer than one page. Prospective Offerors are also encouraged to note any errors in the draft RFP. Errors noted are not included in the five-page limit and shall be submitted as a separate document to SEB10@nnsa.doe.gov.

Site Visits and One-on-One Meetings

To better promote early exchanges of information with potential Offerors, NNSA will host a site visit and one-on-one meetings prior to the release of the final RFP.

The purpose of early exchanges is to is to improve potential Offerors' understanding of Government requirements, thereby allowing potential offerors to judge whether or how they can satisfy the Government's requirement. Information exchanges also enhance the Government's ability to obtain quality services at reasonable prices and increase efficiency in proposal preparation, proposal evaluation, negotiation, and contract award.
