NRMP Payment Instructions

The NRMP accepts the following payment types: credit and debit cards, check, Amazon, PayPal, electronic check (ACH), FedNow, and wire payments in USD. Instructions for each of these methods are listed below. Please note there are separate instructions (#2) for international (non-US bank) wire payment. 1. TO PAY BY CREDIT CARD (\$25,000 limit), ELECTRONIC CHECK (ACH) (\$25,000 limit), AMAZON (\$10,000 limit), OR PAYPAL(\$10,000 limit) via Pay.gov:

Select the Payment Type from the drop-down screen and complete remaining required* fields. Any additional comments can be included in the comments section. Continue to the Payment Info screen. Select method of payment. Complete the required* fields and click the Review and Submit Payment button. To receive an email confirmation, enter your email address. Please include in the cc: AR@hq.doe.gov to ensure the Department of Energy accounts receivable team is aware of your payment.

2. TO PAY BY WIRE FROM A FOREIGN (non-US) BANK:

<u>Please NOTE:</u> Customers are responsible for paying any wire fees or costs. Your transmitting bank may add a processing fee. This fee MUST be paid for by the customer and not deducted from the invoice total. The NRMP will issue a new invoice if wire transfer fees are deducted from the total. Include the text "Our" or "Our charge" in line 71a (see below). Submit remittances to AR@hq.doe.gov.
