Any DB plan maintained by the Contractor, for which NNSA reimburses costs, shall be maintained as a separate DB plan distinct from any other plan which provides credit for service not performed under this Contract. Each Contactor DB plan shall be subjected to an ERISA section 103(a)(3)(c) audit annually, except that every third year the Contractor shall conduct a full-scope audit satisfying ERISA section 103. Alternately, the Contractor may conduct a full-scope audit satisfying ERISA section 103 annually. In years in which a limited-scope audit is conducted, the Contractor shall provide the Contracting Officer with a copy of the qualified Trustee or custodian's certification regarding the investment information that provides the basis for the plan sponsor to satisfy reporting requirements under ERISA section 104 along with the copy of the audit results to which they apply. In all cases, the Contractor shall submit the audit results to the Contracting Officer within ten months of the last day of the DB plan year to which it applies.
