Site Visits and One-on-One Meetings

To better promote early exchanges of information with potential offerors, NNSA will host a site visit and one-on-one meetings at the Y-12 National Security Complex (Y-12) and the Pantex Plant prior to final release of the request for proposals (RFP).

The purpose of early exchanges is to improve potential offerors' understanding of Government requirements, thereby allowing potential offerors to judge whether or how they can satisfy the Government's requirement. Information exchanges also enhance the Government's ability to obtain quality services at reasonable prices and increase efficiency in proposal preparation, proposal evaluation, negotiation, and contract award.
