ACQUISITION LETTER

AUTHORITY

This Acquisition Letter (AL) is issued by the Procurement Executive pursuant to a delegation from the Secretary and under the authority of the Department of Energy Acquisition Regulation (DEAR) Subpart 901.301-71.

Incorporation by reference.

I. PURPOSE.

This AL cancels an alternate procedure specified in the DEAR regarding the treatment afforded contract clauses and solicitation provisions. The alternate procedure required the use of full text, preprinted, contract clause sets in place of the "incorporation by reference" practice which is allowed by section 52.102-1 of the Federal Acquisition Regulation (FAR).

II. BACKGROUND.

When the FAR system was adopted, the Department of Energy (DOE) chose to require the use of full text clause sets rather than incorporation by reference as allowed by the FAR. This practice was followed because certain of the clauses were new while others differed from earlier variations in the predecessor regulation, the Federal Procurement Regulation. After 7 years experience with the text of the FAR clauses, the prohibition on the use of incorporation by reference, found at DEAR 952.102-1, is no longer needed and is being deleted. Supplemental language, regarding incorporation by reference, is substituted in order to specify standard lists of clauses for incorporation by reference by contract type. The Office of Policy will maintain and furnish clause lists.

PART 952 -- SOLICITATION PROVISIONS AND CONTRACT CLAUSES.
(AMENDED)

1. Subsection 952.102-1 is amended by removal of the existing paragraphs (a) and (b) and replacement as follows:

952.102-1 Incorporation by reference.

Subject to the limitations of FAR 52.102, when incorporating contract clauses by reference, contracting activities shall conform to the lists of clauses required for certain contract types which are distributed from time to time by the Office of Policy. Contracting activities using full text clause sets shall ensure that such sets conform in content to the lists issued by the Office of Policy except to the extent that deviations have been granted or more recent clause revisions have been promulgated. Solicitation representations and certifications provisions will also be maintained, updated, and distributed by the Office of Policy for use in solicitations.
