### 2. Movant's interest

Roy R. Stever and Deborah P. Stever, individually, and as trustees of the Roy R. Stever 2000 Living Trust Dated 6/27/00 and the Deborah P. Stever 2000 Living Trust dated 6/27/00, respectively, have diverse interests in land ownership, residence and personal well-being in the Town of Easton, NH, including portions within the White Mountain National Forest. Through trust ownership of the properties designated on Town of Easton, NH Tax Map 4, Lots 22 and 23, as well as all rights accorded to residents of the Town of Easton, NH, the Movants have multiple and diverse interests. Also, Movants have recently signed a Purchase and Sale Agreement with the United States Department of Agriculture to place 122 acres, or thereabouts, of their properties into easement under the terms of the NRCS/Wetlands Reserve Program, in perpetuity. Under the terms of the agreement, the landowners are expected to act as responsible stewards of the land. The Northern Pass project clearly would impact the community of Easton, and potentially threaten the diverse interests of the Movants, described in this section. Therefore, we believe, as Movants, that we have a direct and substantial interest in the outcome of this proceeding, and our interests cannot be adequately represented by other parties, and that we are entitled to intervene in the proceeding.
