On Thursday, June 22, in Washington, D.C., the U.S.-Canada Power System Outage Task Force will hold a conference for stakeholders and the public to comment on the draft of the final report of the Task Force. The draft report assesses the status of implementation of the recommendations made by the Task Force in its 2004 report on the causes of the blackout.

### **Format:**

The conference will be hosted by the Task Force co-leads, Dr. Nawal Kamel and Mr. Kevin Kolevar. Three expert panels, each addressing a group of recommendations, will report to the co-leads on the status of the implementation of the recommendations, as well as on the accuracy of the draft report. Once each panel has completed its presentation, there may be questions from the Task Force co-leads and participants at the head table. The Task co-leads will then ask for questions from the audience. Following the three panels, oral submissions will be invited from the audience, with priority given to representatives of affected states and Ontario.

### **Registration:**

There is no cost to attend, but return the attached registration form by Thursday, June 15, 2006. The draft report will be provided to all registrants prior to the conference.

### **Background:**

The U.S.-Canada Power System Outage Task Force was established to identify the causes of the 2003 power outage that affected North America, and to make recommendations on how to reduce the likelihood of future outages. Following the release of the Task Force report, *Final Report on the August 14, 2003 Blackout in the United States and Canada: Causes and Recommendations*, the governments of the United States and Canada extended the mandate of the Task Force to monitor and report on the implementation of the recommendations.
