This amount takes into consideration FBP's overall performance in the aggregate, both positive and negative. FBP met overall cost, schedule and technical performance and exceeded some of the significant award fee criteria.

Quality and Effectiveness Performing the DOE Contract to include Project Management: The contractor has exceeded some of the significant award fee criteria and has met overall cost, schedule, and technical performance requirements of the contract in the aggregate.

The specific contractual accomplishments include:

- FBP initiated deactivation work in the X-333 building during the period. The project successfully addressed initial organizational and work planning problems and completed activities to completely clear the designated two acre footprint for the material sizing area. FBP has also been very effective in preparing a Training Demonstration Area in the X-700 building to train the X-333 workers and to simulate, test, and demonstrate the new remotely operated segmentation equipment.
- Discrete maintenance and infrastructure project performance has improved with six of seven FY17 projects being completed on time.
- FBP waste management processed and shipped 936 containers of waste and all ash and gunk inventories were processed, packaged, and shipped.
- FBP and DOE contracting officials have worked effectively together on contract administration. This close working relationship was noted as a strength in carefully managing available contract funding levels and funding modifications.

Quality and Effectiveness in Performing ESH&Q & Regulatory: The contractor has exceeded some of the significant award fee criteria and met overall cost, schedule, and technical performance requirements of the contract in the aggregate.

Specific contractual accomplishments include:

- FBP had a Total Recordable Case (TRC) rate of 0.63 in FY17, this is significantly below the EM target rate of 1.1. The FBP Days Away, Restrictions, and Transfers (DARTS) of 0.26 was also well below the EM target rate of 0.60.
- The On-Site Waste Disposal Facility has done an excellent job in addressing the Low Level Waste Facility Federal Review Group (LFRG) Performance Assessment (PA)/Composite Analysis (CA) process in compliance with DOE Order 435.1 requirements.
- FBP developed a high quality Finding of No Significant Impact (FONSI) required under NEPA to support the first transfer of real property at the site (Parcel 1).
