Lamp Recyclers of Louisiana, Inc. dba Lamp Environmental Industries (LEI) operates a Resource Conservation and Recovery Act (RCRA) permitted hazardous waste storage facility located in Hammond, Louisiana under permit number LA0000365668-OP-RN-1 issued by the Louisiana Department of Environmental Quality. This permit authorizes the commercial storage of the following hazardous waste streams;

Ignitable (D001)	Cadmium (D006)
Corrosive (D002)	Chromium (D007)
Reactive (D003)	Lead (D008)
Arsenic (D004)	Mercury (D009)
Barium (D005)	Selenium (D010)
Silver (D011)	Mercury (U151)

LEI has always accepted elemental mercury for recycling, both as a product and as a waste. LEI plans to continue accepting elemental mercury for recycling as long as a domestic market is available. However, LEI would also like the ability to accept elemental mercury for storage, in accordance with the Mercury Export Ban Act of 2008, in the event a domestic recycling option is no longer available or per a customer's request.

Therefore, in accordance with section 5(g)(2)(B) of the Mercury Export Ban Act of 2008, LEI is submitting this letter as a certification that it intends to accept elemental mercury for storage in accordance with its permit issued under section 3005(c) of the Solid Waste Disposal Act (42 U.S.C. 6925(c)), and shall not be subject to the storage prohibition of section 3004(j) of the Solid Waste Disposal Act (42 U.S.C. 6924(j)), if the Secretary is unable to accept the mercury at a facility designated by the Secretary under subsection (a) for reasons beyond the control of LEI. LEI additionally certifies that it will ship the mercury collected for storage to the designated facility when the Secretary is able to accept the mercury, and that LEI will not sell or otherwise place mercury received for storage, excluding mercury destined for recycling domestically, into commerce.
