## NNMCAB Members Attended the 2014 Waste Management Symposia in Phoenix, AZ

he Waste Management Symposia was held March 2 – 7, 2014, in Phoenix, Arizona, at the Phoenix Convention Center. There were participants from around the world present at this conference. This year's NNMCAB attendees included Alex Puglisi and Carlos Valdez.

The first day of the conference, Sunday, Mr. Valdez participated in the Critical Decisions (and tools) for First-time and Experienced Managers (Or how I Learned to Love the Org Chart) Workshop. This was an all day workshop and was presented by James Hylko, who is a Project Manager out of the Paducah and Portsmouth site. This workshop provided the core elements of an effective management training program derived from applying the Department of Energy's Integrated Safety Management System and the Occupational Safety and Health Administration's Voluntary Protection Programs.

From Monday thru Thursday, Mr. Valdez and Mr. Puglisi attended several sessions throughout the day, including Hot Topics in DOE. This seemed to be a very popular session, since the room was fairly large and well attended by participants. For several of the other sessions throughout the week, the Hanford site clean-up seemed to be the selected topic of conversation. On several of the panel discussions, Hanford was used as an example of the type of clean-up being conducted. The discussions also seemed to center around the River Preservation Program and the Tank Waste Farms. Overall, the sessions were very interesting. The panel discus-

## NNMCAB Members Attend the Environmental Justice Conference



NNMCAB members Ms. Angel Quintana from Pojoaque Pueblo, and Ms. Irene Tse-Pe from Pueblo de San Ildefonso, attended the Environmental Justice Conference (EJC) in Washington, D.C. The Conference was held March 26 - 28, 2014 at the Howard University School of Law. The EJC has been an annual event for over 15 years and has hosted keynote speakers that include Deputy Secretary of Energy Daniel Poneman, U.S. Congressional Representatives, and Judg-

es. More than 300 people attended the EJC in 2013, bringing ideas and solutions from across the country, and creating an open communication and information sharing network.

EJC 2014 will host a range of presentations that will cover a broad set of topics, some of which include: US Forest Service Discover the Forest, The U.S. EPA Superfund Program, Sustainability, and Sacred Sites Report and Recommendations. Attendees also have the opportunity to attend panel discussions; an example of which is the Environmental Justice Planning Tools and Practices. EJC 2014 featured Keynote Speakers from the Office of the Secretary of Energy, and Deputy Under Secretary Arthur Blazer, Natural Resources and Environment, United States Department of Agriculture.

# What is the Northern New Mexico Citizen's Advisory Board (NNMCAB)?

Site-Specific Advisory Boards were developed to involve stakeholders more directly in the Department of Energy (DOE) cleanup process. The NNMCAB provides DOE with advice and recommendations concerning: environmental remediation, waste management, and monitoring and surveillance of legacy waste.

#### Who Serves on the NNMCAB?

Membership reflects a broad range of cultures, demographics, and views from citizens in the affected communities and regions. Members include stakeholders from local governments, Tribal Nations, environmental and civic groups, universities, labor organizations, and others. Liaison members to the NNMCAB come from LANL, DOE, the Environmental Protection Agency, and the New Mexico Environment Department.

#### **Board Member Responsibilities**

\* Submitting advice and recommendations to DOE on integral Environmental Management Issues.

- \* Representing and communicating the views of their communities in board discussions.
- \* Keeping the public informed on key issues, upcoming decisions, board recommendations, and public hearings.
- \* Attending the NNMCABs bi-monthly meetings and serving on one of the boards standing committees. Board meetings occur on Wednesdays once every other month from 1:00 p.m. to 5:00 p.m. Committee meetings occur on the 2nd Wednesday of every month from 2:00p.m. to 4:00 p.m.

#### How Can You Get Involved?

Board meetings serve as a two-way exchange between members of the public and the NNMCAB, DOE, and Liaison members. All NNMCAB board meetings have a public comment period through which members of the public can voice their concerns, issues, and submit written comments.

### NNMCAB Chair's Corner

There are eight Environmental Management site specific Advisory Boards around the country; the Northern New Mexico Citizen's Advisory Board (NNMCAB) is one of those Boards. In New Mexico, we affectionately refer to it as the CAB. Over the past two years, the CAB has been doing many good things. One of the biggest accolades the CAB has received nationally over the past year, is its diversity. The CAB currently consists of 20 members; eleven males, nine females, three are Native American, and six are Hispanic. We have one current member that worked at LANL in the past. So when we say that we are the voice of northern New Mexico, we really are the public voice, and not a general stamp of approval for the labs. Having attended several National Chairs meetings around the country, our CAB has quite often been hailed as having a stellar diversity.

Over the past couple of years the CAB

has worked hard at developing good working relationships with the New Mexico Environment Department (NMED). The relationship between NMED and the CAB has not always been healthy, but we have proven to be honest, trustworthy, and transparent with our work and our intentions. NMED has now agreed that using the CAB as a public sounding board is a good idea. This has also helped better the relationship that has developed between LANL and NMED.

The CAB is currently in the process of developing recommendations for FY 2014. In 2013, the CAB submitted nine recommendations. One recommendation triggered an Environmental Assessment for disposal pathways for disposition of the 33-shafts, another spurred the development, by LANL, of a Fact Sheet on risks to Material Disposal Areas by wild fires, and another recommendation that became an item on the agenda for our full-board meetings. The CAB was also instrumental in the development of

clean-up work priorities in 2014 and 2015.

The members have been busy participating in several areas that don't include waste in and around Los Alamos, but in areas that indirectly impact Los Alamos. For example, the CAB provided input into the Environmental Impact Statement for the storage of Mercury, the final disposition of Greater Than Class C waste, full participation in the Regional Coalition of LANL Communities, participation in Waste Management symposiums, and WIPP storage

The CAB continues to stay busy with important legacy and cold war clean-up efforts and looks forward to providing the public service that the citizens of northern New Mexico depend on.
