## **Progress of the Proposed Monkey Island LNG Terminal**

- 1. The following Engineering has been completed since October 1, 2016: Progress and flow diagrams, heat and material balance, detailed project estimates, compressor /driver study, Level 1 EPC Schedule, feed gas specifications, and other pre-FEED activities.
- 2. In conversations with global business executives, the SCT&E LNG project is often referred to as Monkey Island LNG. As of March 8, 2017, the Company completed the Assumed Named Records process with the Harris County Clerk's office and is now formally doing business as Monkey Island LNG.
- 3. An MOU has been signed for an additional 1.0 mtpa toward the project's capacity of 12 mtpa.
- 4. SCT&E LNG continues to engage in advanced negotiations with investment grade offtakers.

## **Date the Project is Expected to be Operational**

SCT&E LNG anticipates that, following the completion of the FERC and DOE approval process, it will begin construction of the LNG export facility and full operations of the facility will begin in 2023/2024.

## **Status of Long-term Offtake Agreements**

As stated above, SCT&E LNG has signed 5.7 mtpa in offtake reservations. Contract negotiations for long-term offtake agreements continue to progress. SCT&E LNG is in negotiations with potential counterparties for tolling capacity at its future liquefaction and export facility on Monkey Island.

## **Status of Long-term Supply Agreements**

As stated above, SCT&E LNG has signed a 20-year fixed price natural gas supply agreement to support its future Liquefied Natural Gas (LNG) facility. Contract negotiations for additional long-term supply agreements continue to progress.
