From this board's opinion, it is all up in smoke. We have to know if the plan includes the plumes and landfills. I personally am not going to go for that, unless I know OEPA is on board with it. If we do not have a path forward, we as a board will be less inclined to say go on over to site D. We will not be able to use that land for anything other than a landfill. If you do not remediate inside Perimeter Road, then we have created an even greater problem.

Galanti: DOE is not making that decision in the Waste Disposition RI/FS. The options are on-site/off-site. I cannot give you a decision. Unless DOE decides to have an on-site disposal cell, it is useless for me to sit here and select a remedy for plumes and landfills. I can tell you that OEPA is hearing your concerns. DOE has to come ask OEPA to do something else. OEPA is not opposed to a better cleanup. However, that decision is up to OEPA.

Minter: When will that decision be made?

Galanti: It will probably be 2014 before you see anything on that decision.

Waste Disposition & Recycling Subcommittee Update by Chair Richard Snyder: *Snyder:* The Waste Disposition & Recycling Subcommittee met on January 15. The subcommittee had a review of the Suspension Details by Dan Thiel, FBP. The subcommittee met again on February 12. The subcommittee had a presentation on Upcoming Waste Disposition Operation by Dean Lobdell, FBP.

Public Comment:

Lawson: I am a former guard at the plant. I would hope the public would get the entire report of the habitat study from OU and it is made available for the public to be able to read the entire report and not a revised copy. I question DOE being more open. I differ with that statement on some issues. I have some of their information that is actually criminal. I have the original and the redacted copies along with their legal people saying that what they are doing is criminal. Therefore, I do not believe that DOE is being completely open. That is some of my concern. That one plume model is extremely close to an item that was brought here from Huntington, WV and buried on this site. I know it has been capped, but I have serious concerns about the water.

Sea: NOVA seconds Mr. Lawson's call for the Ohio University (OU) study along with all other contracted studies by DOE. Because of falsification, the public does not trust DOE. Therefore, we request all unedited studies of unclassified material that has been contracted by DOE. The reason the Los Alamos school system received eight million dollars from DOE is they have dozens of advisory boards that pressed the legislators into supporting the school system. Why is this SSAB not writing recommendations to support your school system? Why are you not talking about that? I heard three members state that they represent the public. The public did not elect you, DOE appointed you, therefore; you do not represent the public. The community is opposed to an on-site waste disposal. NOVA proposed a third solution to have a mixed on-site/off-site disposal. If this solution is not seriously perused as much as the other options, DOE will be in volition of Comprehensive Environmental Response, Compensation and Liability Act (CERCLA).

Manuta: I have been judging the science fairs at Shawnee State for about 25 years. The leadership there informed me that the way the outreach funds are more money will be allocated to other areas than to science fairs. There are not very many working scientists in southern Ohio, I am one of them. When we are working with children, I think it is important that scientists work with them.

How the RI/FS Supports the Decision

RI/FS

- Defines the problem

Record of Decision

 Addresses public comments and selects solution

The Remedial Investigation/Feasibility Study (RI/FS) is a technical document. It serves as the foundation for decision-making. The RI/FS does not provide a preferred solution.



Waste Disposition RI/FS

- Will support a decision between off-site disposal, and on-site with some off-site disposal, for waste generated under DFF&O and CERCLA actions.
- Recycling and/or reuse is part of each disposal alternative.
- Identifies fill sources for OSDC from contaminated surface and shallow soil, groundwater contamination areas, and landfills over top of or adjacent to groundwater contamination areas.
- The DFF&O and CERCLA's required nine criteria are used to conduct the technical-, risk-, and cost-based balancing evaluation of alternatives.
