Categorical Exclusion Determination Form

<u>Proposed Action Title</u>: Purdue University -- Bio-enabled Lightweight Metallic Structures with Ultrahigh Specific Strengths for Reduced Weight, Energy Use, and Emissions

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): W. Lafayette, Indiana

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop new bio-inspired ultra-lightweight structural materials designed to enable reductions in weight, energy use, and emissions in the transportation industries. Specifically, the project team will (1) model, synthesize, and characterize low-density Titanium (Ti) bio-inspired structures to determine the structure with the highest specific strength; (2) develop scaling laws for predicting the strengths of macroscale, hierarchical Ti structures; and (3) design a bio-inspired scalable Ti structures that meets the strength and density requirements. If successful, dramatic reductions in fuel use and emissions may be achieved by replacing current metallic components in vehicles and aircraft with mechanically-robust metallic structures of lower weight. For example, each 1% reduction in highway vehicle weight would save 1.0-1.4 billion gallons of fuel per year in the U.S. alone, with an associated drop in emissions.

Project activities will be conducted at an existing facility at Purdue University (W. Lafayette, IN) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facility to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
