Re: Notification to All Known Manufacturers of Waiver Publication

Dear Ms. deButts and Ms. Armstrong,

Big Ass Solutions commends DOE for their thorough review of this isolated but impactful difficulty in the final rule and thank DOE for granting BAS an interim waiver.

On March 23rd, 2018, your office published Big Ass Solutions' petition for waiver in the Federal Register, identified by case number 2017-011, and Docket number EERE-2017-BT-WAV-0049. As of March 28th, 2018, written notice has been mailed by BAS to all known manufacturers believed to be potentially impacted by this test procedure waiver. The notice stated that DOE published an interim waiver and petition for waiver in the Federal Register on March 23, 2018 and a statement that DOE will receive and consider timely written comments on the petition for waiver.
