Description:

**A9** Information gathering,

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information analysis, and dissemination (including, but not limited to, document publication and distribution, and classroom training and dissemination informational programs), but not including site characterization or environmental monitoring. B3.6 Smallscale **laboratory** operations, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and research and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a development, concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

## Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Fraunhofer USA Center for Energy Innovation (Fraunhofer CEI) to design, fabricate, and test the first ceramic Membrane Distillation (MD) membranes that perform in chemical and/or thermal environments that are too extreme for polymeric MD membranes. Project work would occur at Fraunhofer CEI in Connecticut and Fraunhofer research and development facilities in Germany.

This project is focused on membrane development through modification of existing ceramic Ultra Filtration membranes to make them function in MD applications. Project work would occur within existing laboratory and research and development facilities. These facilities are designed for this type of work and would utilize standard equipment; therefore no modifications, new permits, additional licenses and/or authorizations would be necessary. No ground disturbing activities, no changes in operation of existing facilities, and no installation of equipment outdoors would occur for project activities. The project would involve the use and handling of hazardous materials, including solvents and produced water from the oil and gas industry. All such handling would occur in-lab and follow proper hazardous material handling and disposal practices. All hazardous materials would be managed and disposed of in accordance with federal, state, and local environmental regulations. Existing facility health and safety policies and procedures would be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments. Additional policies and procedures would be implemented as necessary as new health and safety risks are identified. Non-hazardous wastes generated by the project would follow each facility's chemical and waste management handling procedures for disposal and compliance. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

Based on the review of the proposal, DOE has determined the proposal fits within the class of action(s) and the integral elements of Appendix B to Subpart D of 10 CFR 1021 outlined in the DOE categorical exclusion(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410(2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant actions, or an improper interim action. This proposal is categorically excluded from further NEPA review. Further, DOE has determined that the work to be carried out at Fraunhofer's facilities in Germany are exempt from further review pursuant to Section 5.1.1 of the DOE Final Guidelines for Implementation of Executive Order 12114; "Environmental Effects Abroad of Major Federal Actions."
