Brief Description of Proposal: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to conduct routine access road maintenance along the Curecanti-Blue Mesa (CCI-BM) 115-kV Transmission Line, located in Gunnison and Montrose Counties, Colorado. The work would occur intermittently along the CCI-BM Transmission Line on existing access roads between Structures 0/1 and 4/3. Structures 0/1 to 2/7 are located in Critical Gunnison Sage-grouse Habitat. The roads also provide access to the Curecanti-Poncha (CCI-PON) 230-kV Transmission Line from CCI Substation to Structure 1/4. All road work would be confined to WAPA's existing access roads. No new roads will be constructed.

The Transmission Line and access roads pass through a mixture of private lands, and those administered by the Bureau of Land Management. Damaged sections of existing access roads would be graded and repaired to allow safe passage of rubber-treaded vehicles. Maintenance would include repair of borrow ditches, installation or repair of water bars and culverts, vegetation removal, and access road grading and rock removal. Equipment utilized for road maintenance would include rubber-treaded motor grader, track dozer, backhoe, dump truck, and a skid-steer loader. To access the work areas maintenance crews shall use the existing access roads.

This Categorical Exclusion (CX) supersedes the original CX issued July 18, 2017, with an original expiration date of December 31, 2018. The proposed action described within remains the same as the originally-issued CX. The Special Stipulations (Section D, below) have been updated for this CX and supersede all original stipulations.

- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
 - Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally-recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). - 2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
 - 3) The proposal is not “connected” to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211.

C. Special Stipulations Pertaining to the Proposal:

1. If the scope of work of this project changes, WAPA’s Environment Department must be contacted to determine whether additional environmental review is required.
2. **This Categorical Exclusion expires on December 31, 2021.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR’s Environment Department must be contacted for an updated environmental review.
3. **The following spans are located within Gunnison Sage-grouse critical habitat: Structures 0/1 to 2/8.**

Within this span, maintenance crews shall take the following precautions to avoid or minimize any potential disturbance to the Gunnison Sage-grouse and its critical habitat:

- a. **WAPA will avoid the Gunnison Sage-grouse lekking and early brood rearing seasons between March 1 and July 15.**
- b. **No herbicide application is authorized.**

- c. Road maintenance crews shall not widen any road, such that the only sagebrush that will be removed or trimmed is that which has encroached into the road from the side of the road, or within the existing 2-tracks.**
 - d. Vehicles will use existing access roads and will remain on them.**
4. Any injured or dead birds encountered on WAPA's ROW must be immediately reported to the RMR Avian Protection Leads by telephone at 970-593-8803 or 970-278-7119. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.
 5. If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately, RMR's Archaeologist must be contacted immediately. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
 6. If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately and RMR's Archaeologist must be notified immediately by telephone (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
 7. To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
 8. Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
