- A. <u>Brief Description of Proposal</u>: Western Area Power Administration (WAPA) proposes to conduct routine maintenance on existing asphalt surfaces within the Loveland Area Power Marketing Operations Center (LLM). This work would occur within WAPA's LLM fenced compound within the City of Loveland, Colorado. Maintenance would include filling and sealing any cracks in the existing asphalt, covering the area with seal coat, and painting and striping the repaired asphalt surfaces for traffic control. No new roads would be constructed. Equipment used for this project would include sealcoat machines, crack filling machines, striping paint systems and/or trucks, and work trucks.

D. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, WAPA's Environmental Division must be contacted to determine whether additional environmental review is required.
- 2) This Categorical Exclusion expires three years from the signature date. If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, WAPA's Environmental Division must be contacted for an updated environmental review.
- 3) Measures shall be put in place to prevent spills of crackseal, asphalt and sealcoat materials from entering storm drains or other pathways to water located at the LLM. All crackseal, asphalt, and sealcoat materials shall be stored away from storm drains or other pathways to water.
- 4) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
- **E.** <u>Determination</u>: Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
