CLASS 2 NOTICE

M-Area and Metallurgical Laboratory Hazardous Waste Management Facilities Permit Application Modification Requested

The United States Department of Energy (DOE)-Savannah River Operations Office has requested from the South Carolina Department of Health and Environmental Control (SCDHEC) a modification to Savannah River Site's (SRS) 2000 Resource Conservation and Recovery Act (RCRA) Part B Permit Renewal Application for Volume III. The modification details post-closure reporting and operations at the M-Area and Metallurgical Laboratory Hazardous Waste Management Facilities (HWMFs).

The modification (Revision 8 of Volume III) requests changes to the groundwater monitoring well network to include newly installed wells, to expand the 1,4-dioxane groundwater monitoring network, and to document the well network for the A-2 Air Stripper Shutdown. The application also summarizes characterization efforts that were completed for the M-Area Abandoned Process Sewer Lines, the A-014 Outfall, and the A-2 Air Stripper. The corrective action schedules for the vadose zone, Southern Sector and Western Sector were also updated.

This notice begins a 60-day comment period. More information, including the actual permit application, is available for review and copying at the DOE Public Reading Room located in the University of South Carolina-Aiken Library, or by contacting personnel identified in this notice. The Permittee's compliance history during the life of the permit being modified is available from the SCDHEC.

A public meeting will be held on Thursday, June 2, 2016 at 3:00 p.m. at the Aiken County Public Library. Representatives from SRS will be available to answer questions on the modification. Written Comments may be sent to SCDHEC. All comments will be considered in the final decision.
