## CLASS 2 NOTICE

### *F-Area and H-Area Hazardous Waste Management Facilities Permit Application Modification Requested*

The United States Department of Energy (DOE) - Savannah River Operations Office has requested from the South Carolina Department of Health and Environmental Control (SCDHEC) modifications to the Savannah River Site's (SRS) 2000 Resource Conservation and Recovery Act (RCRA) Part B Permit Renewal Application for Volumes IV and V. Volume IV modifications are associated with the F-Area Hazardous Waste Management Facility (HWMF) and Volume V modifications are associated with the H-Area HWMF.

The modifications (Revision 2 of Volumes IV and V) reflect the current permitted operations associated with these two post closure facilities as issued in the February 11, 2014, Hazardous and Mixed Waste Permit (Permit Number SC1 890 008 989) and include additional changes to the monitoring well network.

This notice begins a 60-day comment period. More information, including the actual permit application, is available for review and copying at the DOE Public Reading Room at the Gregg-Graniteville Library at the University of South Carolina-Aiken Library in Aiken, SC, or by contacting personnel identified in this notice. The Permittee's compliance history during the life of the permit being modified is available from SCDHEC.

A public meeting will be held on Tuesday, June 14, 2016 at 3:00 PM at the Aiken County Public Library. Representatives from SRS will be available to answer questions on the modification. Written comments may be sent to SCDHEC. All comments will be considered in the final decision.
