ORDER GRANTING REQUEST TO AMEND AUTHORIZATIONS TO IMPORT LIQUEFIED NATURAL GAS TO REFLECT CORPORATE NAME CHANGE

DOE/FE ORDER NO. 1115-B DOE/FE ORDER NO. 2752-B DOE/FE ORDER NO. 3647-A

On November 7, 1995, the Office of Fossil Energy (FE) of the Department of Energy (DOE) issued DOE/FE Order No. 1115 (FE Docket No. 95-100-LNG), as amended by DOE/FE Order No. 1115-A, under section 3 of the Natural Gas Act (NGA). That order granted the entity then-known as GDF SUEZ Gas NA LLC authorization to import liquefied natural gas (LNG) by vessel from Trinidad and other countries, up to a total volume equivalent to 100 billion cubic feet (Bcf) of natural gas per year, for a term of 40 years that began on May 6, 1999, and extends through May 5, 2039. On February 16, 2010, DOE/FE issued DOE/FE Order No. 2752 (FE

Docket No. 09-135-LNG), as amended by DOE/FE Order No. 2752-A, granting GDF SUEZ Gas NA LLC authorization to import LNG by vessel from Yemen, up to a total volume equivalent to 100 Bcf of natural gas per year, for a term of 10 years that began on February 19, 2010, and extends through February 18, 2020. Finally, on May 28, 2015, DOE/FE issued DOE/FE Order No. 3647 (FE Docket No. 15-69-LNG), granting GDF SUEZ Gas NA LLC authorization to import LNG from Canada by truck, up to a total volume equivalent to 1 Bcf of natural gas, for a two-year term that began on May 23, 2015, and extends through May 22, 2017.

On November 2, 2016, DOE/FE was notified that GDF SUEZ Gas NA LLC's corporate name had been changed to "ENGIE Gas & LNG LLC" (ENGIE LNG NA), effective December 3, 2015. ENGIE LNG NA states that there has been no change in control or ownership of GDF SUEZ Gas NA LLC; rather, the parent company changed its brand name from "GDF Suez" to "ENGIE," and its subsidiaries were obligated to incorporate the new brand into their company name.

Finding good cause, DOE/FE hereby grants ENGIE LNG NA's request to amend the specified authorizations to reflect its corporate name change. Accordingly, pursuant to section 3 of the Natural Gas Act, it is hereby ordered that DOE/FE Order Nos. 1115-A, 2752-A and 3647 are amended to substitute ENGIE Gas & LNG LLC as the importer of LNG, effective December 3, 2015. All obligations arising under those orders apply to ENGIE Gas & LNG LLC, and all other terms and conditions of those orders shall remain in full force and effect.
