Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to authorize the administration of a prize competition regarding pumped storage hydropower, known as the Furthering Advancements to Shorten Time (FAST) Commissioning for Pumped-Storage Hydropower Prize.

Through the FAST prize DOE seeks to encourage solutions to reduce time, costs, and risks for commissioning pumped storage hydropower with a goal of reducing commissioning time from the current average of ten years to less than five. The FAST prize contest would consist of three stages.

The first stage would be limited to submission of concept papers. Concept papers would include a problem statement, description of the proposed innovation, technical feasibility description, market feasibility description, team qualifications, and needs that could be addressed by a national lab partner. Up to 10 concept papers would be chosen to proceed to stage two, the incubation stage.

In stage two participants chosen to continue would be partnered with a DOE national lab which would provide up to 50 hours of technical support and advice. Work would be limited to analysis and technical advice. At the end of stage two participants would submit a final 10 page report and power point presentation (slide deck) on their idea.

Stage three, the pitch contest, would consist of participants presenting their idea to a live audience. Participants would be judged on their pitch as well as their 10 page report. Up to three participants would be chosen to receive combined cash prizes as well as additional technical support from a national lab.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

NEPA PROVISION

DOE has made a final NEPA determination.

Include the following condition in the financial assistance agreement:

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
