- A. <u>Brief Description of Proposal</u>: Western Area Power Administration (WAPA), Rocky Mountain Region, proposes to re-route a portion of the right-of-way (ROW) on its Glendale Diamond Creek (GDE-DMC) 12.47-kV Distribution Line. As part of the ROW re-route, work would involve removing Structures 42 and 43 on the existing GDE-DMC 12.47-kV Distribution Line. These structures are located on private lands and public lands administered by the U.S. Department of Interior Bureau of Reclamation in Park County, Wyoming. Three new structures, 42, 42A, and 43, would be installed in a new ROW easement. The full scope of this project would include removing existing structures and filling in the holes; auguring new holes, installing new wood poles, backfilling, and installing new hardware. Equipment for this project may include rubber-treaded vehicles (bucket trucks, truck-mounted augers, cranes, utility trucks, pickup trucks and a skid-steer loader). All work would be confined to WAPA's ROW easements. Existing access roads would be used; no road maintenance or road construction is authorized.

An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). D. <u>Special Stipulations Pertaining to the Proposal</u>:

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on December 31, 2021**. If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) Any injured or orphaned birds, and all active nest relocations, must be immediately reported to the RMR Avian Protection Leads at (970) 593-8803 or (970) 278-7119. Any dead birds must be reported to the RMR Avian Protection Leads within twenty-four (24) hours of discovery. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the USFWS.
- 4) Transmission line and substation components must be designed and constructed in conformance with the most current editions of Suggested Practices for Avian Protection on Power Lines and Reducing Avian Collisions with Power Lines, both published by the Avian Power Line Interaction Committee (APLIC) to minimize avian collision and electrocution risk while maintaining safe and reliable electrical service.

- 5) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately, RMR's Archaeologist must be contacted immediately. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 6) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately and RMR's Archaeologist must be notified immediately by telephone (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 7) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 8) WAPA shall exercise care to preserve the natural landscape and shall conduct this project to prevent any unnecessary destruction, scarring, or defacing of the natural surroundings in the project vicinity. Except where clearing is required for permanent works, approved construction roads, or excavation operations, vegetation shall be preserved and shall be protected from damage by WAPA's maintenance operations and equipment. If operations or equipment cause terrain damage, the maintenance crew shall repair the damage.
- 9) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).

- **E.** <u>Determination</u>: Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
