- A. <u>Brief Description of Proposal</u>: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to replace two 34.5 kV oil circuit breakers (OCB) and associated equipment at WAPA's Lingle Substation (L), located in Goshen County, Wyoming. The existing 342 and 442 OCB's would be replaced with more dependable Sulfur Hexaflouride (SF<sub>6</sub>) gas breakers. In addition to the replacement of the OCB breakers, seven switches, voltage transformers, arresters, associated conductor, associated electrical equipment, control cable and cable trench, and site development and foundation removal would occur. All proposed activities will occur within the existing L fenced perimeter. To access the work area, maintenance crews would use existing access roads. No road maintenance activities are authorized as part of this Categorical Exclusion (CX).

- C. <u>Regulatory Requirements in 10 CFR Part 1021.410 (b)</u>: (See full text in regulation and attached checklist.)
  - (1) The proposed action fits within a class of actions listed in Appendix A or B to Subpart D.

For classes of actions listed in Appendix B, the following conditions are integral elements. To fit within a class, the proposal <u>must not</u>:

- Threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders;
- Require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities;
- Disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases;
- Have the potential to cause significant impacts on environmentally sensitive resources. An environmentally sensitive resource is typically a resource that has been identified as needing protection through Executive Order, statute, or regulation by Federal, State, or local government, or a federally-recognized Indian tribe. An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to, those listed in paragraph B. (4) (see Attachment A).

- (2) There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- (3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR Part 1506.1 or 10 CFR Part 1021.211.

#### D. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on December 31, 2022**. If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) Any injured or orphaned birds, and all active nest relocations, must be immediately reported to the RMR Avian Protection Leads at 970-593-8803 or 970-278-7119. Any dead birds must be reported to the RMR Avian Protection Leads within twenty-four (24) hours of discovery. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.
- 4) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately, RMR's Archaeologist must be contacted immediately. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 5) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100-feet of the discovery area must halt immediately and RMR's Archaeologist must be notified immediately by telephone (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 6) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.

- 7) Lingle Substation is covered by a current Spill Prevention, Control, and Countermeasure (SPCC) Plan. RMR's SPCC Coordinators must be notified prior to the installation, replacement, or removal of any oil-containing equipment, or placement of fill material, to ensure activities are in compliance with the requirements of the SPCC plan. Any changes in oil quantities must be provided to the SPCC Coordinators at the completion of this project.
- 8) The Contractor shall record quantities of SF<sub>6</sub>, including:
  - a. Nameplate capacity in pounds of SF<sub>6</sub> gas containing equipment.
  - b. Record pounds of SF<sub>6</sub> gas stored in containers, before transferring into energized equipment.
  - c. Record pounds of SF<sub>6</sub> gas left in containers, after transferring into energized equipment.
  - d. Pounds of SF<sub>6</sub> gas purchased from equipment manufacturers or distributors.
  - e. Pounds of SF<sub>6</sub> gas returned to suppliers.
  - f. Scales used to weigh cylinders must be accurate to within +/- 2 pounds and must have current calibration sticker.
- 9) Substation components must be designed and constructed in conformance with the most current editions of *Suggested Practices for Avian Protection on Power Lines* and *Reducing Avian Collisions with Power Lines*, both published by the Avian Power Line Interaction Committee (APLIC), to minimize avian collision and electrocution risk while maintaining safe and reliable electrical service.
- E. <u>Determination</u>: Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
