

- Y-12 is located in Oak Ridge , TN



Missions

•Pantex Plant has several national security missions that protect our country and our allies around the world. Pantex provides the nuclear deterrent for our nation and allies, ensures our stockpile is strong and viable, reduces the total nuclear weapons in the stockpile, and supports the stockpile as the High Explosives Center of Excellence.

•Y-12 National Security Complex has three primary national security missions that protect our country and our allies around the world: maintaining the U.S. nuclear stockpile, reducing global threats, and fueling the U.S. Nuclear Navy.



 - Ask questions if unsure
- Follow instructions for submission of offers
- Understand offer evaluation criteria
- Complete and sign all documents requested with offer submittal
- Late, partial, or incomplete offers may not be considered



Tips for Success

- Update profiles DSBS and SAM
 - Use company email address and remember password
 - NAICS Code should reflect the principal work being performed
- Create concise Capability Statements
- Attention to detail / Performance Requirements
- Know and Understand the Terms and Conditions
 - Review them prior to RFP
- Find good partners beforehand
 - Consider subcontract opportunities
- Attend pre-bid meetings
