A. <u>Brief Description of Proposal</u>: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to replace two vacuum circuit breakers and associated equipment at WAPA's Flaming Gorge (FGE) Switchyard, located in Daggett County, Utah. The existing vacuum circuit breakers, 4032 (13.2-kV) and 4132 (24.9-kV), will be replaced in-kind with new vacuum circuit breakers. One existing breaker has failed and the other breaker is scheduled for replacement. All work will occur within the existing FGE Switchyard fenced perimeter. Equipment required for this project includes skid-steers, work trucks, and equipment trailers. Maintenance crews will use existing access roads; no road maintenance or road construction is authorized as part of this Categorical Exclusion.

B. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on December 31, 2020.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) Any injured or orphaned birds, and all active nest relocations, must be immediately reported to the RMR Avian Protection Lead at (970) 593-8803. Any dead birds must be reported to the RMR Avian Protection Lead within twenty-four (24) hours of discovery. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.
- 4) Substation components must be designed and constructed in conformance with the most current editions of *Suggested Practices for Avian Protection on Power Lines* and *Reducing Avian Collisions with Power Lines*, both published by the Avian Power Line Interaction Committee (APLIC), to minimize avian collision and electrocution risk while maintaining safe and reliable electrical service.
- 5) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and RMR's Archaeologist must be contacted immediately at (970) 461-7563. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.

- 6) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and RMR's Archaeologist must be notified immediately at (970) 461-7563 (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 7) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 8) Flaming Gorge Switchyard is covered by a current Spill Prevention, Control, and Countermeasure (SPCC) Plan. RMR's SPCC Coordinators must be notified prior to the installation, replacement, or removal of any oil-containing equipment, or placement of fill material, to ensure activities are in compliance with the requirements of the SPCC plan.
