A. <u>Brief Description of Proposal</u>: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to install a new culvert on the existing access road for the Buffalo Head (BHD) Switchyard in Natrona County, Wyoming. A low area in the road approximately 230 feet south of the BHD entry gate has been retaining moisture and becoming muddy with vehicle traffic. An 18-inch diameter by 22-foot long culvert will be installed in the road prism to direct water away from the road. Gravel will be applied on the existing access road after the culvert has been installed to further address the mud issues. Equipment used for this project may include excavators, dump trucks, skid-steers, equipment trailers, and work trucks. Work will occur on public lands managed by the Bureau of Land Management (BLM). This work will be confined to WAPA's existing access road prism and right-of-way (ROW), and no new roads will be constructed.

B. <u>Special Stipulations Pertaining to the Proposal</u>:

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) **This Categorical Exclusion expires on December 31, 2020.** If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and RMR's Archaeologist must be contacted immediately at (970) 461-7563. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 4) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and RMR's Archaeologist must be notified immediately at (970) 461-7563 (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by RMR's Archaeologist.
- 5) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 6) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).
