To Whom It May Concern:

Pursuant to Condition J of DOE/FE Order 3968, Condition B of DOE/FE Order 3968-A, and Condition M of DOE/FE Order 4373 ("Orders"), Driftwood LNG LLC ("DWLNG") is providing herein the semi-annual status report for the Driftwood LNG Facility for the period April 1, 2019, through September 30, 2019.

On April 18, 2019, the Federal Energy Regulatory Commission ("FERC") issued an Order Granting Authorization Under Section 3 of the Natural Gas Act and Issuing Certificates ("Order") granting the necessary authorization for the construction and operation of the Driftwood LNG Facility (CP17-117-000) and Driftwood Pipeline Project (CP17-118-000).

On April 26, 2019, DWLNG submitted Implementation Plan - A to the FERC to address compliance with general conditions set forth in Appendix A of the FERC Order. Specifically, DWLNG submitted responses to Conditions 1-14, 26-29, and 108-111.

On May 2, 2019, the Department of Energy issued Opinion and Order granting Long-Term Authorization to Export Liquefied Natural Gas to Non-Free Trade Agreement Nations (Order No. 4373) for the DWLNG Project.

On May 3, 2019, the United States Corps of Engineers issued Permit No. MVN-2016-01501-WII for the Driftwood LNG Facility and Driftwood Pipeline Project.

On May 22, 2019, DWLNG submitted Implementation Plan - B to the FERC to illustrate compliance with Conditions 24 and 30, which are required prior to pile driving activities at the DWLNG Facility.

On June 6, 2019, FERC issued Limited Notice to Proceed with Test Piles at the DWLNG Facility.

On July 10, 2019, Tellurian Inc. entered into definitive agreements with Total Delaware, Inc. (Total) and Total Gas & Power North America, Inc. (Total Gas & Power), subsidiaries of Total S.A., for Total Gas & Power to purchase one million tonnes per annum (mtpa) of liquefied natural gas (LNG) from the Driftwood LNG terminal. In addition, Tellurian and Total Gas & Power entered into a definitive sales and purchase agreement for an additional 1.5 mtpa of LNG from Tellurian's LNG offtake volumes from Driftwood.

On September 21, 2019, Tellurian Inc. and Petronet LNG Limited INDIA (PLL) signed a Memorandum of Understanding (MOU) wherein Petronet and its affiliates intend to negotiate the purchase of up to five million tonnes per annum (5 mtpa) of liquefied natural gas (LNG) from Driftwood.

DWLNG is continuing to develop and negotiate terms for long-term LNG export contracts and long-term supply contracts for the Driftwood LNG Facility. In accordance with Conditions D(1) and D(2) of DOE/FE Order 3968, Condition B of DOE/FE Order 3968-A, and Conditions I(1) and I(2) of DOE/FE Order 4373, DWLNG will file copies of long-term contracts upon execution.
