Description:

A9 Information gathering,

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information analysis, and dissemination (including, but not limited to, document publication and distribution, and classroom training and dissemination informational programs), but not including site characterization or environmental monitoring. B3.6 Smallscale **laboratory** operations, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and research and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a development, concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to The Pennsylvania State University (Penn State) for the investigation of a practical and safe natural gas storage method based on an absorption mechanism using a newly developed hydrocarbon super-absorbent polymer (SAP) called "Petrogel". All research activities would be carried out in Penn State research laboratories (University Park, PA). The project would be completed over three Budget Periods (BPs), with a Go/No-Go Decision Point in between each BP.

Proposed project activities at Penn State would include bench-scale laboratory work for material synthesis, structure characterization, polymer process, and natural gas absorption/desorption evaluation. Project work would occur in existing laboratories designed for this type of work that would utilize standard laboratory equipment; therefore no modifications, new permits, additional licenses and/or authorizations would be necessary. No ground disturbing activities, no changes in the operation of existing facilities, and no installation of equipment outdoors would occur for project activities. The project would involve bench-scale chemicals (solvents, monomers, catalysts, etc.) and chemical reactions, which would be handled inside the laboratory following established lab operational practices and waste chemical disposal practices so the project is not expected to pose health and safety hazards to the public or researchers involved. All students and postdoctoral researchers would be trained and required to pass a laboratory safety exam before working in the laboratory. The major products of the project are polyolefin solid materials that are not toxic under normal operational conditions. The by-products generated during the chemical reactions would mostly be water-soluble salts and organic solvents. These materials would be disposed of following Penn State chemical waste disposal procedures by professional personnel. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
