# Medicine Bow Substation to Medicine Bow Rural Metering Station Direct Buried Fiber Optic Installation Carbon County, Wyoming Project Number: 2017-096 Expiration Date: December 31, 2022

A. <u>Brief Description of Proposal</u>: Western Area Power Administration (WAPA), Rocky Mountain Region (RMR), proposes to install new direct-buried fiber optic cable between its existing Medicine Bow Substation (MB) and Hot Springs Rural Electric Association's existing Medicine Bow Rural Metering Station (MBR). Approximately 0.1 miles of fiber optic cable would be buried along WAPA's existing Medicine Bow Tap – Medicine Bow (MBT-MB), Miracle Mile – Snowy Range No. 1 (MM-SNG 1), and Medicine Bow Tap – Medicine Bow Rural (MBT-MBR) 115-kV Transmission Line rights-of-way (ROWs) on privately-owned lands in Carbon County, Wyoming. This project is part of WAPA's ongoing program to update and improve its communication system. Equipment including a ditch witch, skid steer, and work trucks would be used to install the new buried fiber via open trenching. All work would be restricted to the existing ROWs, and no roadwork would occur.

This Categorical Exclusion (CX) replaces the original CX issued January 12, 2018, with an original expiration date of December 31, 2019. The proposed action remains the same; however, the Special Stipulations (Section B, below) have been updated for this CX and replace all original CX stipulations.

## B. Special Stipulations Pertaining to the Proposal:

- 1) If the scope of work of this project changes, RMR's Environment Department must be contacted to determine whether additional environmental review is required.
- 2) This Categorical Exclusion expires on December 31, 2022. If all project work has not been completed by the expiration date, or if the need for an environmental compliance extension is anticipated, RMR's Environment Department must be contacted for an updated environmental review.
- 3) If any cultural resources are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and an RMR Archaeologist must be contacted immediately at (970) 461-7563 or (970) 461-7214. Work in the area of discovery must not resume until notification to proceed is provided by an RMR Archaeologist.
- 4) If any possible human remains are inadvertently discovered during implementation of the proposed action, work within 100 feet of the discovery area must halt immediately and an RMR Archaeologist must be notified immediately at (970) 461-7563 or (970) 461-7214 (no later than 24 hours from the time of discovery). A reasonable effort must be made to protect the remains from looting and/or further damage. Work in the area of discovery must not resume until notification to proceed is provided by an RMR Archaeologist.

- 5) Any injured or orphaned birds, and all active nest relocations, must be immediately reported to the RMR Avian Protection Lead at (970) 593-8803. Any dead birds must be reported to the RMR Avian Protection Lead within twenty-four (24) hours of discovery. Additional documentation, such as photographs and GPS coordinates, may be requested to support RMR's reporting requirements to the U.S. Fish and Wildlife Service.
- 6) To prevent the transport of non-native and invasive plants and animals, including noxious weeds and aquatic nuisance species, work crews must thoroughly wash all vehicles and equipment (trailers, trucks, UTVs, etc.) before entering the action area and working on the project.
- 7) Activities involving the use of fuel, oil, hydraulic fluid, or other petroleum products must comply with RMR's Spill Response Plan (SRP).

An action may be categorically excluded if, although sensitive resources are present, the action would not have the potential to cause significant impacts on those resources (such as construction of a building with its foundation well above a sole-source aquifer or upland surface soil removal on a site that has wetlands). Environmentally sensitive resources include, but are not limited to those listed in paragraph B. (4) (see Attachment A).
- 2) There are no extraordinary circumstances related to the proposal that may affect *the significance of the environmental effects of the proposal.*
- 3) The proposal is not "connected" to other actions with potentially significant impacts, is not related to other proposed actions with cumulatively significant impacts, and is not precluded by 40 CFR Part 1506.1 or 10 CFR Part 1021.211.
- **E.** <u>Determination</u>: Based on my review of information provided to me and in my possession concerning the proposed action, I have determined that the proposed action fits within the specified class of actions, the other regulatory requirements set forth above are met, and the proposed action is categorically excluded from requirements for an EA or an EIS.
