To Whom It May Concern:

Pursuant to Condition J of DOE/FE Order 3968, Condition B of DOE/FE Order 3968-A, and Condition M of DOE/FE Order 4373 ("Orders"), Driftwood LNG LLC ("DWLNG") is providing herein the semi-annual status report for the Driftwood LNG Facility for the period October 1, 2019, through March 31, 2020.

On October 18, 2019, Driftwood submitted Implementation Plan - C to the Federal Energy Regulatory Commission (FERC) to address compliance with certain conditions set forth in Appendix A of the FERC Order. Specifically, Driftwood submitted responses to Conditions 19-23, 30, and 35-36 related to site preparation activities.

On November 12, 2019, Driftwood submitted Supplement to Implementation Plan – C to FERC to illustrate compliance with Conditions 22 and 32-34, which were the remaining conditions required to be addressed for site preparation activities.

On December 2, 2019, Driftwood submitted Supplement to Implementation Plan – C to FERC to demonstrate compliance with Condition 33.

On December 11, 2019, FERC issued Notice to Proceed with Site Preparation at the DWLNG Facility.

On December 11, 2019, DWLNG submitted a Construction Authorization Extension Request to the Louisiana Department of Environmental Quality (LDEQ) for the Driftwood LNG Facility Title V Permit No. 0520-00504-V0 and PSD Permit No. PSD-LA-824.

On January 6, 2020, LDEQ issued an extension for the Commencement of Construction Deadline for the Driftwood LNG Facility to July 10, 2021.

On January 27, 2020, DWPL submitted the Louisiana Natural and Scenic Rivers System Permit Application to the Louisiana Department of Wildlife and Fisheries.

On February 5, 2020, Driftwood submitted Implementation Plan – D to illustrate compliance with certain conditions set forth in Appendix A of the FERC Order. Specifically, DWLNG submitted a response to Condition 30, which is required prior to construction of piles and foundations at the DWLNG Facility.

On March 24, 2020, Driftwood requested the Louisiana Department of Natural Resources' (LDNR) Office of Coastal Management grant a two-year extension pursuant to requirements contained in the Rules and Procedures for Coastal Use Permits (Title 43:l.723.D).

On March 25, 2020, DWLNG submitted Requests for Extension for Aeronautical Study Nos. 2018-ASW-15414-OE (Waterway LNG Carrier – North Berth), 2018-ASW-15415-OE (Waterway LNG Carrier – Middle Berth), and 2018-ASW-15416-OE (Waterway LNG Carrier – South Berth) to the Federal Aviation Administration.

DWLNG is continuing to develop and negotiate terms for long-term LNG export contracts and long-term supply contracts for the Driftwood LNG Facility. In accordance with Conditions D(1) and D(2) of DOE/FE Order 3968, Condition B of DOE/FE Order 3968-A, and Conditions I(1) and I(2) of DOE/FE Order 4373, DWLNG will file copies of long-term contracts upon execution.
