Description:

**A9** Information gathering,

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information analysis, and dissemination (including, but not limited to, document publication and distribution, and classroom training and dissemination informational programs), but not including site characterization or environmental monitoring. B3.6 Smallscale **laboratory** operations, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and research and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a development, concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

# Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Worcester Polytechnic Institute for the research and development of innovative dryer platforms for the food and forest products industry to reduce energy consumption and to improve product quality. Three novel energy-efficient drying technologies would be used as the basis for the development of smart drying prototypes for drying food, pulp and paper. These drying technologies would be developed at Worcester Polytechnic Institute and the University of Illinois. The project would be completed over three Budget Periods (BPs). This NEPA determination is applicable to all three BPs.

Proposed activities in each BP would focus on developing the three drying technology based platforms, with concurrent energy and quality analysis, testing of the sensors for the different platforms, and physics-based Artificial Intelligence (AI) machine learning. Multiple partner companies would provide mentoring and advising to assist with the transfer of the developed technologies.

Proposed project activities by location are listed below:

Worcester Polytechnic Institute (Center for Advanced Research in Drying), Worcester, MA

Development of nozzles for all three drying technologies, sensors, and AI machine learning

University of Illinois, Urbana-Champagne, IL

• Development of one drying technology, sensors, AI machine learning, and control system

Oak Ridge National Laboratory, Oak Ridge, TN

Technical assistance on drying technology

Project work would involve the use of machinery operating at moderate temperatures. All such handling would occur in controlled, purpose built facilities and would be managed in accordance with existing safety policies, and follow

Federal, state, and local environmental regulations. No modifications, new permits or change in the use, mission, or operation of any facility would be required.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.
