<u>Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021)</u>: B4.11 – Electric Power Substations and Interconnection Facilities.

<u>Description of the Proposed Action</u>: The Bonneville Power Administration (BPA) is proposing to attach new conductors to Midstate Electric Cooperatives' new transmission line structures located outside of the BPA La Pine substation yard to the west, and complete the associated work within the substation control house. Within the substation control house BPA would install metering equipment provided by Midstate, auxiliary relays, cable in rack 22, modify relay settings as needed for Bays 4, 5, and 6, and modify the La Pine Substation drawings. BPA would attach the last span conductors of about 150 to 300 feet, including insulators and hardware provided by Midstate, to dead end structures inside the La Pine substation.

<u>Findings</u>: In accordance with Section 1021.410(b) of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, July 9, 1996; 61 FR 64608, Dec. 6, 1996, 76 FR 63764, Nov. 14, 2011), BPA has determined that the proposed action:

- (1) fits within a class of actions listed in Appendix B of 10 CFR 1021, Subpart D (see attached Environmental Checklist);
- (2) does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal; and
- (3) has not been segmented to meet the definition of a categorical exclusion.

Based on these determinations, BPA finds that the proposed action is categorically excluded from further NEPA review.
