Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and dissemination informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to authorize the administration of a prize competition, known as the Waves to Water Prize, designed to develop wave energy powered desalination systems.

As originally proposed, the Waves to Water Prize would be a 4-Stage contest to accelerate the development of small, modular, wave-powered desalination systems capable of potable drinking water. The four stages are CONCEPT, DESIGN, CREATE and DRINK. The Prize competition has now been amended to include a 5th Stage, ADAPT, to be held between the DESIGN and CREATE stages.

DOE previously completed one NEPA review which reviewed CONCEPT, DESIGN, and CREATE (GFO-WavesPrize.001,CX A9, 6/6/2019). This NEPA review is only for the ADAPT stage.

The ADAPT stage would involve competitors providing to DOE detailed technical plans originally created in the DESIGN Stage, but now adapted to be site specific for the proposed testing site. Jennette's Pier, in Nags Head, North Carolina. Work under the ADAPT Stage is limited to design work and supporting analysis of their proposed system.

Stage 4 remains restricted until further NEPA review is completed.

The prize contest would be administered by DOE and the National Renewable Energy Lab (NREL). In addition NREL could hire additional reviewers and/or entities to help administer the prize competition including reviewing individual projects and completing administrative tasks.
