Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and dissemination informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Newport Partners to develop and test a novel residential hybrid heat pump (HHP) system and optimized control (OC) platform. The HHP system and OC platform would be designed to be more energy efficient than comparable fossil-fuel fired furnaces. Both hardware and software would be developed as part of the project. Performance testing of the HHP system and OC platform would then be performed at an existing, occupied residential location.

A residential location has not yet been selected for performance testing of the HHP system and OC platform. Performance testing would be performed as part of Task 3. Tasks 4 and 5 would then consist of modeling and reporting, based on the results of testing and analysis. Newport Partners would select a location after the project has commenced, in coordination with industry partners. Selection of the testing location would only proceed after screening criteria has been developed based on the completion of the three tasks prior to Task 3, which include the formation of an industry advisory group and development of the OC platform. Accordingly, this NEPA Determination will only be applicable to Tasks 0, 1, and 2. Tasks 3 - 5 are restricted until Newport Partners selects a testing location and submits all relevant information to DOE for review.

Proposed project activities for Tasks 0, 1 and 2 include development of an intellectual project management plan, stakeholder engagement, formation of an industry advisory group, computer modeling/energy simulations, and OC platform design and development. OC platform design and development would consist of computer-based development and design activities.

All project activities would be performed by Newport Partners at its office locations in Davidsonville, MD, Loveland, CO, and Schenectady, NY. The proposed project would not result in any physical modifications to existing facilities, ground disturbing activities, outdoor installations/deployments, or changes to the use, mission, or operation of existing facilities. No additional permits or authorizations would be required to complete project activities.

Because project work would consist of office-based task work, no significant health and safety hazards are anticipated. Nonetheless, Newport Partners would adhere to established corporate health and safety policies and procedures. Newport Partners would observe all applicable Federal, state, and local health, safety, and environmental regulations.
