Proposed Action or Project Description:

This EEC covers the removal of the inlet HEPA Filters and the respective housings that were used to support Cabinet 25 operations in F091. This EEC covers the installation of blanks for the resultant penetrations after the inlet HEPA filter housings have been removed. This EEC also covers the installation of one new exterior HEPA filter and housing that will act as an inlet for Cabinet-25. This new exterior housing shall connect to one of the remaining inlet penetrations. Cabinet-25 has been out of service for over a decade and has no radioactive material hold-up assigned.
