Project Title: Design and Installation for Replacement of Cuno Filter with Porvair Filter (ZR.378F)

Proposed Action or Project Description:

The Cuno Filters installed downstream of the RGDs (ZR.378F) have flanged connections that are not ideal for that part of the process. It is suspected that there is process leak into the glovebox at the flanges. It has been decided to generate a DCF to replace the Cuno filters with Porvair filters (formerly Fairey Filter Elements). These filters have VCR fittings and will be more leak tight. Design is being developed. Implementation will occur at later date.
