Proposed Action Title: Hight-Tech, LLC -- Advanced Catalyst Manufacturing Enabled by Direct Joule Heating

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Baltimore, MD; College Park, MD; Rockville, MD

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to design and manufacture high-entropy alloy (HEA) catalysts for highly efficient ammonia synthesis by using Joule heating. Specifically, the project team will (1) scale up the manufacturing of HEA nanoparticles using an innovative process, (2) study and evaluate NH<sub>3</sub> synthesis on HEA catalysts, and (3) optimize catalyst layers for improvement of single-pass yield of ammonia. If successful, the project team will demonstrate ultra-fast and scalable catalyst manufacturing, capable of >50% single-pass yield of NH<sub>3</sub>, which will substantially reduce the cost and energy consumption of NH<sub>3</sub> synthesis process in industry. Additionally, the process may cut the carbon footprint of NH<sub>3</sub> synthesis by more than 50%.

Project activities will be conducted at existing facilities at Hight-Tech, LLC (Rockville, MD), University of Maryland, College Park (College Park, MD), and Johns Hopkins University (Baltimore, MD) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.


