Proposed Action Title: Zakuro, LLC -- Solid-state Battery Manufacturing Scale-up

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to transition Li metal anode, Ceramic Membrane, and load-bearing Cermet cathode (LCMC) processing from the current lab batch process to a conventional roll-to-roll process. Specifically, the project team will (1) optimize ceramic processing; (2) develop interface engineering, catholyte, and cell integration; and (3) improve materials processing and tool optimization. If successful, the project team will demonstrate 225 mAh cells which contain no flammable liquid electrolyte, with twice the energy density of Li-ion (1000 Wh/l), high specific energy (333 Wh/kg) and retain 80% of its capacity after charging and discharging 500 times.

Project activities will be conducted at existing facilities at University of Michigan (Ann Arbor, MI) and Zakuro, LLC (Ann Arbor, MI) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.
