Proposed Action or Project Description:

The current 234-H Main Side HVAC equipment was installed in the mid 1950's. 234-H HVAC Main Side Supply Fan #1, 2, & 3 and Damper shall be replaced with like equipment that is more reliable and maintainable. The replacement supply fan and damper move outside air that has been conditioned by the Main Side Air Handling Unit and provide necessary supply ventilation to 234-H.
