Re: Request to Amend Long-Term Authorization to Export Natural Gas – Order 4227

Dear Ms. Sweeney and Mr. Nussdorf:

On August 8, 2018, the Office of Fossil Energy ("FE") of the Department of Energy ("DOE") issued Order No. 4227 (the "Order") pursuant to section 3 of the Natural Gas Act ("NGA") ¹ and applicable DOE/FE regulations. ² The Order granted COPEQ Trading Co. ("COPEQ"), a Texas corporation, long-term authority to export natural gas to Mexico, in the amount of up to 24.78 billion cubic feet ("Bcf") per year ("Bcf/yr"). This authorization commenced on July 1, 2018 and was made effective for a ten-year term. By this letter, COPEQ requests that, effective January 1, 2021, the DOE/FE amend Order No. 4227 reflecting an increased export authorization of 7.19 Bcf/yr (for a total export authorization of 31.97 Bcf/yr) and an extended authorization term ending on January 1, 2031.

I. Request for Increased and Extended Export Authorization

COPEQ expects to increase its natural gas purchases in the United States by approximately 19,709 Mcf/day (equal to 7.19 Bcf/yr), which will be procured under short-term supply agreements and in the spot market.³ This natural gas will be transported to the international border with Mexico under a gas transportation agreement with Kinder Morgan Pipelines, dated May 27, 2020, and having an initial term of ten years (the "New KM GTA").⁴

Under the New KM GTA, COPEQ has the right to transport up to 19,709 Mcf/day of gas from receipt points within Texas to various delivery points on the international border between the United States and Mexico. While the New KM GTA is effective May 27, 2020, service is expected to commence on January 1, 2021.

After including the 19,709 Mcf/day increase in export volumes, COPEQ expects to export a total of 31.97 Bcf/yr to Mexico (reflecting the originally-authorized volume of 24.78 Bcf/yr plus 7.19 Bcf/yr for new volumes). As a result of this increase and the 2021 expected commencement date of the New KM GTA, COPEQ requests that Order No. 4227 be amended, effective January 1, 2021, to reflect the following: (i) a 7.19 Bcf/yr increase in authorized export volumes for a total of 31.97 Bcf/yr and (ii) an extended export authorization term ending on January 1, 2031 (which is ten years following the service commencement date of the New KM GTA). Except for those specifically referenced in this letter, all conditions and material facts from COPEQ's July 19, 2018 application remain unchanged.

II. Natural Gas Act – Public Interest Standard

Under Section 3(c) of the Natural Gas Act,⁵ as amended by section 201 of Energy Policy Act of 1992,⁶ exporting natural gas to countries where the United States has an effective free trade agreement (requiring national treatment for trade in natural gas) is deemed to be in the public interest. The United States has in effect a free trade agreement with Mexico requiring national treatment in trade for natural gas, and therefore, COPEQ submits that its requests made hereunder are consistent with public interest.

III. Request for Confidential Treatment

A copy of the New KM GTA is enclosed with this letter. Consistent with applicable law, ⁷ COPEQ requests that this contract be afforded confidential treatment because it contains COPEQ's highly confidential commercial information that is normally held confidential, and which, if disclosed, would cause COPEQ substantial competitive harm.

IV. Administrative Compliance

A paper copy of this letter, along with a confidential copy of the New KM GTA, have been mailed to the DOE/FE. The required \$50 processing fee has been submitted to the DOE/FE by electronic payment.
