We wanted to let you know that, on review of this application in DOE/FE Docket 20-99-LNG, it appears to request duplicate authority to what is currently granted in <u>DOE FE Docket No. 18-15-LNG/Order No. 4206</u>. That order (specifically, Ordering Paragraph A) authorizes the export of "domestically produced LNG and previously imported LNG," and does not limit the exports to commissioning volumes. Although we appreciate your diligence in seeking to avoid any lapse in authority, you may continue relying on Order No. 4206 until it expires.

Accordingly, we ask that you either:

- (1) Withdraw the new application and re-submit it closer to the needed effective date; or
- (2) Request via email that DOE/FE hold the new application in abeyance in FE Docket No. 20-99-LNG. Under this option, it will be Southern LNG's responsibility to email DOE/FE to request that we act on the application in early 2021.

If you opt for #2, we presumably would process the application to be a continuation of Order No. 4206 with a proposed effective date of April 1, 2021 (two years from the effective date of Order No. 4206, March 31, 2019), unless you request otherwise.
