Pursuant to DOE Order Nos. 3147-B and 3978-C, Ordering Paragraph I (ii), Golden Pass LNG Terminal LLC ("GPLNG") hereby submits for filing, under seal, a non-redacted copy of an executed long-term contract associated with the long-term supply of natural gas to the Golden Pass LNG Terminal.


In accordance with Ordering Paragraph I (ii), GPLNG provides the following reason why the redacted or non-disclosed information should be exempt from public disclosure:

The non-redacted copy includes highly sensitive confidential commercial, financial, technical and proprietary information, the release of which would result in substantial competitive harm. Disclosure of this information would put GPLNG at a competitive disadvantage in negotiations with other potential natural gas suppliers, as the information could provide those parties with information of negotiated terms and conditions. Moreover, disclosure of this information could also cause competitive harm to GPLNG by disclosing competitive business strategies associated with the procurement of natural gas supplies, transportation and confidential commercial and financial information that is unique to GPLNG.

In accordance with Ordering Paragraph I (ii), GPLNG is also submitting for public posting a summary of major provisions of a Base Contract for Sale and Purchase of Natural Gas dated as of May 1, 2020 and Transaction Confirmation, dated as of May 1, 2020 between GPLNG and Williams Energy Resources LLC attached as Attachment A hereto; and
