**PRIVILEGED AND CONFIDENTIAL** Submission of Contracts and Summary of Major Provisions of Contracts for Public Posting

Dear Ms. Sweeney:

Venture Global Calcasieu Pass, LLC ("Calcasieu Pass") was granted long-term, multi-contract authority to export liquefied natural gas (LNG) to (1) nations with which the United States has not entered into a Free Trade Agreement (FTA) requiring the national treatment of natural gas in Order No. 4346 issued in FE Docket Nos. 13-69-LNG, 14-88-LNG, and 15-25-LNG on March 5, 2019, and (2) FTA nations in earlier orders in those same dockets. Ordering Paragraph I(i) of Order No. 4346 requires Calcasieu Pass to file a non-redacted copy of all executed long-term contracts associated with the long-term supply of natural gas to its Project within thirty days of contract execution. Ordering Paragraph (D) of each of the FTA authorizations reflects the same filing requirement and further provides that, if a contract is filed under seal and subject to a claim of confidentiality or privilege, Calcasieu Pass also must file for public posting a summary of the non-proprietary, major provisions of the contract.

Calcasieu Pass recently entered into long-term gas supply contracts with two counter-parties. First, on December 14, 2020, Calcasieu Pass and Spire Marketing Inc. ("SPI") entered into a

Base Contract for Sale and Purchase of Natural Gas, and a related Transaction Confirmation.<sup>2</sup> Second, on January 5, 2021, Calcasieu Pass and Tenaska Marketing Ventures ("Tenaska") entered into a Base Contract for Sale and Purchase of Natural Gas, and a related Transaction Confirmation.<sup>3</sup> Under each agreement, Calcasieu Pass will purchase natural gas on a long-term basis from the counter-party.

These gas supply contracts are highly confidential and contain commercially valuable and proprietary information, the disclosure of which would cause competitive and financial harm to the parties to the contract. Accordingly, in accordance with the requirements of its export authorizations, Calcasieu Pass submits here summaries, for public posting, of the major, non-proprietary provisions of the two supply contract. The summary utilizes the template followed by other LNG export projects when filing long-term gas supply contracts.

In addition, Calcasieu Pass also is transmitting -- in a confidential, separate transmission directed solely to the addressee -- full and unredacted copies of the executed agreements. Calcasieu Pass respectfully requests that the contracts be treated and maintained as confidential to the greatest extent permitted by law.
