This report meets the requirements of section 141 of the Energy Policy Act of 2005 (EPACT 2005) and section 305 of the Energy Independence and Security Act of 2007 (EISA 2007). Because the reporting intervals and requirements are similar for the EPACT 2005 and EISA 2007 reports, DOE provides a consolidated report.

DOE is required by EPACT 2005 and EISA 2007 to provide semi-annual implementation reports pertaining to DOE's deadlines regarding new or amended energy conservation standards. This implementation report includes a summary of DOE's progress relative to the last report provided in July 2019. Submission of this report was delayed, but the Department commits to striving to meet the Congressionally-mandated schedule moving forward.

### **Executive Summary**

This semi-annual implementation report covers past, present, and future DOE rulemaking activities within the Appliance and Equipment Standards Program. This report responds to legislative language set forth in section 141 of the Energy Policy Act of 2005 (EPACT 2005), Pub. L. 109-58, and section 305 of the Energy Independence and Security Act of 2007 (EISA 2007), Pub. L. 110-140, to provide semi-annual updates of the U.S. Department of Energy's (DOE's) progress with respect to rulemaking actions regarding the implementation of energy conservation standards and test procedures.

In the following sections, DOE details the notices it has issued since the last implementation report, as well as any statutory deadlines DOE has missed, and rulemakings DOE is currently developing to meet the requirements of EPACT 2005, EISA 2007, the American Energy Manufacturing Technical Corrections Act (AEMTCA), and any other subsequent amendments to the Energy Policy and Conservation Act (EPCA).

Since the last report in July 2019, DOE has completed the following actions related to energy conservation standards and test procedures:

- Seventy-one (71) energy conservation standards rulemaking notices, as set forth in the below section in reverse chronological order by type of notice and publication date.
  - These include fifteen (15) final actions (ceiling fans, commercial air compressors, commercial packaged boilers, dishwashers, evaporatively-cooled and water-cooled commercial package air conditioners, fluorescent lamp ballasts, general service incandescent lamps, general service lamps, portable air conditioners, procedures for evaluating statutory factors for use in new or revised energy conservation standards, process improvement rule, residential clothes washers and consumer clothes dryers, residential furnaces and commercial water heaters, small electric motors, and uninterruptible power supplies); one (1) supplemental notice of proposed rulemaking; one (1) notice of supplemental proposed interpretive rulemaking; seven (7) notices of proposed rulemaking; one (1) notices of proposed determination; two (2) notice of preliminary analysis; four (4) notices of data availability; and thirty-two (32) requests for information.
- Fifty-two (52) test procedure rulemaking notices, as set forth in the below section in reverse chronological order by type of notice and publication date.
  - These include nine (9) final rules (ceiling fans, cooking products, dedicated-purpose pool pump motors, fluorescent lamp ballasts, room air conditioners, showerheads, small electric motors and electric motors, test procedure interim waiver process, and walk-in coolers and freezers); one (1) delay of effective date; one (1) notice of

supplemental proposed rulemaking; eighteen (18) notices of proposed rulemaking; and twenty-three (23) requests for information pertaining to test procedures.

DOE also includes a table listing ongoing rulemakings with outstanding judicial or statutory deadlines. DOE is working to complete these rulemakings as expeditiously as possible, along with a number of other ongoing rulemakings. DOE plans to publish thirty-one (31) actions related to energy conservation standards by the end of 2021, including four (4) final rules. Additionally, DOE plans to publish thirty-one (31) actions related to test procedures before the end of 2021, including six (6) final rules.

## I. Legislative Language

This report responds to legislative language set forth in section 141 of the Energy Policy Act of 2005 (EPACT 2005), Pub. L. 109-58, and section 305 of the Energy Independence and Security Act of 2007 (EISA 2007), Pub. L. 110-140, to provide semi-annual updates of the U.S. Department of Energy's progress with respect to rulemaking actions regarding the implementation of energy conservation standards and test procedures.

Specifically, section 141 of EPACT 2005 provides: "(a) INITIAL REPORT.—The Secretary shall submit a report to Congress regarding each new or revised energy conservation or water use standard which the Secretary has failed to issue in conformance with the deadlines established in the Energy Policy and Conservation Act. Such report shall state the reasons why the Secretary has failed to comply with the deadline for issuances of the new or revised standard and set forth the Secretary's plan for expeditiously prescribing such new or revised standard. The Secretary's initial report shall be submitted not later than 6 months following enactment of this Act and subsequent reports shall be submitted whenever the Secretary determines that additional deadlines for issuance of new or revised standards have been missed. (b) IMPLEMENTATION REPORT.—Every 6 months following the submission of a report under subsection (a) until the adoption of a new or revised standard described in such report, the Secretary shall submit to the Congress an implementation report describing the Secretary's progress in implementing the Secretary's plan or the issuance of the new or revised standard."

Section 305 of EISA 2007 provides in relevant part: "'(v) REPORTS.—The Secretary shall promptly submit to the Committee on Energy and Commerce of the House of Representatives and the Committee on Energy and Natural Resources of the Senate a progress report every 180 days on compliance with this subparagraph, including a specific plan to remedy any failures to comply with deadlines for action established under this subparagraph.'"

Because the topics and reporting intervals in section 141 of EPACT 2005 and section 305 of EISA 2007 are substantially similar, DOE began consolidating the reports, starting with the first EISA 2007 implementation report in February 2008. This document constitutes the twenty-fourth semi-annual EPACT 2005 implementation report and the twenty-first semi-annual EISA 2007 implementation report.
